PREFATORY NOTE

WHEN the War Memorial was under consideration, the Committee discussed the feasibility of inscribing the names of the dead on the pedestal, but found it difficult within the space available to do so. It was then resolved that a Roll of Honour should be carefully compiled and copies deposited with the Parish Council and the Trustees of the Cambuslang Institute for preservation. The resolution was surely a wise one; for, as now printed, the names of those who fell in the field or who died of wounds or sickness can be easily read and at the same time viewed comprehensively; whereas, on the monument itself, engraved in small letters, besides being difficult to find, they, doubtless, in a few years owing to weather conditions would have become obliterated and so have been lost as a permanent record.

As now presented what a Roll it is! At a glance one visualises the loss of young lives and the fact that it represents one parish only—Cambuslang—will help present and future parishioners, in some measure, to realise the magnitude of the sacrifice made by loyal sons throughout the Empire.

As a Roll of Honour it will be cherished. It is due to the memory of the dead that their self-sacrifice should be recorded. True life is not measured by the grains of sand in the glass—

Circles are praised not that abound
In largeness, but the exactly round :
So life we praise that doth excel
Not in much time but acting well.

WAR MEMORIAL

THE Great War is over, and the battle won. The glorious traditions of our Nation have been upheld, and the cause of liberty has been vindicated.

It is therefore fitting for the purpose of this record to give a résumé of the proceedings relative to the erection of the Cambuslang War Memorial in the Public Park. The idea, common throughout the country, of perpetuating the memory of the brave lads who fought and fell in the Great War, emanated from the Parish Council.

At a statutory meeting of that Authority held on 5th December, 1918, under the chairmanship of Mr. Archibald McDiarmid, J.P., it was decided to call a meeting of the general public. The meeting representative of all the interests in the Parish was held in the Institute, Cambuslang, on 26th March, 1919, when the following resolution was after full consideration unanimously agreed to, namely :

“ That a Monument be erected to the Memory of the Men who have fallen, and the sum over applied to any other useful Object.”

An Executive Committee was appointed with power to devise means to raise funds and to investigate the question of a suitable site and bring the scheme into operation.

The Executive Committee on 4th November, 1919, after conference and careful consideration and with unanimity agreed :

- (1) That the Monument to be erected to the memory of the men of Cambuslang Parish who fell in the Great War should be of a simple, worthy, and enduring character.

- (2) That any balance of the fund subscribed should be held in trust and applied for behoof of widows and dependents of the men of Cambuslang Parish who fell in battle, or who died of wounds or sickness directly resulting from military service.

The appeal for subscriptions met with a generous response, the sum of £2,800 being subscribed. Mr. Alexander Proudfoot, A.R.A., was commissioned to design, execute, and erect the memorial at a cost of £1,460, the sum of £1,000 being devoted to the Widows and Orphans Fund.

In raising the necessary funds the Executive Committee were ably assisted by the Ladies' Committee.

CONSTITUTION

The subscribers to the Cambuslang War Memorial having met in the Cambuslang Institute on Thursday, 10th February, 1921, after conference and deliberation adopted the following constitution :

1. The Fund amounting to the sum of £1,000 shall be designated the Cambuslang War Memorial Fund (hereinafter referred to as " the Fund "). It shall be administered for the relief of Widows and Dependents of men of Cambuslang Parish who fell in battle or who died of wounds or sickness directly resulting from naval or military service.

2. The Fund shall be held by and vested in three Trustees. The first Trustees shall be : Chairman of Parish Council, *ex officio* ; James G. Jenkins, Esq., J.P. ; Andrew Clark, Esq., J.P. ; two being a quorum.

3. The Funds shall be administered by an Executive Committee consisting of six persons, one half of whom shall be women (three being a quorum). The duties of the Executive Committee shall be to inquire into and investigate all cases requiring relief, and after investigation to dispense from the Fund, or the income thereof, such amount of relief as shall seem proper.

The Executive Committee may appoint a Sub-committee consisting of two of their own number to investigate all claims for relief and to report ; but pecuniary relief shall in all cases be finally adjudged by the Executive Committee alone, who shall not be bound to accept the recommendation of such Sub-committee.

4. An honorary secretary and treasurer shall be appointed to act along with the Executive Committee ; but the office of Secretary and Treasurer may be held by the same person. The Secretary and Treasurer shall be members, *ex officio*, of the Executive Committee. Mr. Peter McLean, was appointed Honorary Secretary and Mr. John A. Webster was appointed Honorary Treasurer.

5. The Executive Committee shall have power from time to time to fix the amount of the allowance to widows and dependents and the endurance of the same. They shall also have power to make a capital payment for behoof of a widow or dependent, if in their opinion, such payment would be helpful to the advancement in life of such widow or dependent, but no capital payment shall exceed the sum of £10 to any individual recipient.

6. When the Executive shall have arranged the grants to be paid to widows and dependents, the Treasurer shall make up an account thereof which shall be signed by himself and two members of the Executive Committee, and on presentation of the same to the Trustees a cheque shall be passed by them for the amount set forth in said account, the Grants shall be dispensed by the Executive Committee.

7. The Executive Committee shall appoint the time and place of its meetings for administering the Fund.

8. Once in every year, so long as there are Funds to dispense, the Subscribers to the Fund shall be convened to a Meeting to be held in the month of March or April, at such place and time as may be fixed by the Executive Committee, notice of said meeting being made by advertisement in a newspaper circulating in Cambuslang ; and at such Meeting a Balance Sheet shall be submitted by the Treasurer showing the capital and revenue as at 31st December immediately preceding. Such Balance Sheet shall be audited by one or more auditors to be nominated by the Trustees. At said Annual Meeting of Subscribers any vacancy occasioned by death or resignation of a Trustee shall be filled up by the election of another Trustee. At such Annual Meeting the six members of the Executive Committee and also the Secretary and Treasurer shall be appointed, it being declared, however, that in the event of any vacancy occurring in the Executive during the currency of any year, the remaining acting members of the Executive Committee may appoint an interim member who shall hold office from the date of appointment until next Annual Meeting.

9. The Executive Committee may, if they think fit, act alone with the Committee or Executive of the Soldiers' and Sailors' Families Association, or with any similar Committee or Association dispensing charitable funds for behoof of widows and dependents of Cambuslang men who fell in battle or who died of wounds or sickness directly resulting from naval or military service : and if they elect to do so, they may augment from time to time any grant made by the said Soldiers' and Sailors' Families Association or other kindred Association.

10. The Executive Committee may accept from time to time any donation to the Fund, which donations shall be added to capital account and expended in terms of articles 1 and 5.

11. Where a subscriber to the Fund is a private firm or a public incorporated Company such firm or Company may appoint one person to represent it at the Annual Meeting.

12. The financial business transactions of the Executive shall be duly and regularly recorded in a Cash Book or Ledger by the Treasurer and a Minute of the Meetings shall be kept by the Secretary, all which books and Accounts may at any time be inspected by the Trustees.

13. In the event of any question arising at any time touching the meaning or interpretation of any of the foregoing articles, any such question shall be
