

### CAMBUSLANG.

Lance-Corporal Edward Goodlet, 7th H.L.I., married, and resided at 10 Church Street, Cambuslang, was reported missing, but official notification was received yesterday that he was killed in the Dardanelles on 12th July. He was 25 years of age, and prior to the war was a miner in Gilbertfield Colliery, Cambuslang.

### DUNDEE.

Mr Miller, 281 Hilltown, has received official intimation that his son, Joseph Miller, 1st Black Watch, died of wounds on 22nd July. Deceased was acting as a bomb-thrower, when a shell burst over him, killing an officer and severely wounding Miller. He died from his injuries in ten minutes. Private Miller, who was 29 years of age, was a reservist, having served 9 years with the Black Watch.

Official intimation has come to hand of the death of L.-Cpl. David Malcolm, of the 8th Gordon Highlanders. In a letter to deceased's wife, who lives at 281 Hilltown, a chaplain states that Malcolm was killed in action on the 9th inst.

### GLASGOW.

James Somerville (17), 10th Scottish Rifles, and the son of Mr Robert Somerville, 103 Glenpark Street, died in France on 11th August from wounds received on July 25.

Robert Morris, 1st R.S.F., whose mother resides at 413 Gallowgate, is intimated as having died of wounds received in France on 27th July. Morris was 24 years of age, and had served six years with the 2nd Scottish Rifles.

Hugh Dougal Wylie, 1/7th H.L.I., was killed at the Dardanelles on 12th July. He was 36 years of age, and was formerly employed in Carntyne Steel Casting Foundry. He is survived by a widow and six children, who reside at 4 Colvend Street, Bridgeton.

Andrew M'Gregor, 1st A. and S. Highlanders, has been intimated to his sister, Mrs M'Leod, 28 Albert Street, Townhead, as having died in France of wounds received in action on the 14th July. Private M'Gregor, who was in India when war was declared, was 23 years of age, and had completed six years' service.

Acting-Sgt. William M'Knight, 1st Gordon Highlanders, was killed on 22nd ult. He was twenty-one years of age, and enlisted three years ago. Two brothers are also enlisted. His mother resides at 33 Paterson Street.

John Morrison M'Swan, 1/5th H.L.I., is officially announced as having been killed by a sniper whilst attending to wounded on July 18. He was a printer to trade, and his parents reside at 64 Seamore Street.

Able Seaman George M'Ardle is officially announced as having been lost in the sinking of H.M.S. Ramsey on the 8th inst. He had been a member of the Clyde Division, R.N.V.R., for three years, and prior to the war was employed as a baker. He resided at 55 Craigmount Drive, Maryhill.

Archibald Murray, 1/5th H.L.I., killed at the Dardanelles. Prior to enlisting in the Territorials, Murray was employed as an apprentice iron turner in the Clyde Engine Works, Govan. His parents reside at 41 Crossburn Street, Glasgow.

### GLENGARNOCK.

Andrew Shakevitch, killed at the Dardanelles, was a member of Glengarnock Section, D Company, 4th R.S.F. He was of Polish extraction, and resided with his parents at Glengarnock, where his services as interpreter were often in requisition.

### GRANGEMOUTH.

Official intimation has been received that Sapper Alexander Thomson, R.E., was killed at the Dardanelles on 8th August. He was a son of Mr James Thomson, blacksmith, Grangemouth, 28 years of age, and had been a number of years clerk at the Falkirk Post Office.

### KELSO.

There is reason to believe that Alexander Forbes, 1st K.O.S.B., has been killed at the Dardanelles. He was officially reported missing as from the 4th June, but his father has received a letter from an elder son, who had been in touch with comrades, and who had stated that they had been present at his burial. He came of a soldiering family, his father, who was for many years in the same regiment, being Pipe-Major of the Kelso Fife and Drum Band.

### KILMARNOCK.

James B. Buntine, 4th R.S.F., 47 High Street, Kilmarnock, killed at the Dardanelles on 12th July, was 36 years of age, and is survived by a widow and one child.

Mrs Reynolds, 130 Campbell Street, Kilmarnock, has received intimation that her son, Robert Reynolds, 5th R.S.F., was killed at the Dardanelles on 13th July. Prior to enlisting he worked as a miner.

Alexander Hynds, 7th Royal Scots, son of Mrs Hynds, 15 Townholm, Kilmarnock, previously posted missing, is now reported killed in the Dardanelles on 28th June. He was 22 years of age and married.

### KINROSS.

Sgt. John Malcolm, 8th Bat. Black Watch, died in France, served four years in the Royal Marines, and was a good shot, and winner of numerous prizes for shooting. He was 29 years of age. His parents reside in Kirkgate Cottage, Kinross.

### PEEBLES.

Mrs James M'Lean, of Peebles, who is at present on holiday at Irvine, has received official notification that her husband, Cpl. James M'Lean, of the 2nd Bat. R.S.F., was killed on 2nd August in France. He was a painter at Peebles at the outbreak of the war, and was only five weeks in France. He was 26 years of age. Mrs M'Lean is an Irvine woman.

### POLLOKSHAWS.

James Couper, Pollokshaws and Thornliebank Company, 1/6th A. and S. Hrs. (Renfrewshire Territorials), has been shot by a sniper. He was 20 years of age, and resided at 60. Wodrow Street. When mobilisation took place he was employed by the Corporation of Glasgow as a lamplighter.

Cpl. Charles Maxwell, 10th Bat. Canadian Contingent (killed), was a son of the late Mr Robert Maxwell, Wilson Street, Pollokshaws. When the war broke out he was farming at Maxstone, Saskatchewan.

### RUTHERGLEN.

Mrs Hudson, 24 Greenhill Road, has received official intimation that her husband, George Hudson, 1/7th H.L.I., has died of wounds received in the Dardanelles. He was employed in Dixon's Pits. He leaves a widow and one child. His father and mother reside in Regent Street.

### TROON.

Sgt. James M'Cormack, 1/5th R.S.F., is officially reported killed at the Dardanelles on 12th July. When war broke out, Sgt. M'Cormack was a corporal in the Troon Company of Territorials, in which he had served for four years. On leaving for active service he was promoted Lance-Sergeant, and was subsequently raised to the rank of sergeant. He was the second son of Mr James M'Cormack, Barassie Street. Sgt. M'Cormack followed the occupation of upholsterer, and was 19 years of age.
